### Juror: Andrew Helt

Andrew Helt has been on staff as a Fine Art Consultant at the Rice Gallery of Fine Art since 2005. In that time he has co-curated an average of five fine art exhibitions per year in addition to marketing, selling, and installing original fine art throughout the Kansas City area and beyond.

In addition to his daily gallery duties, he also serves the local arts community by organizing and planning special community art events, exhibitions and festivals for charitable and/or community organizations, most notably the annual Stems Plein Air Paint.

### **Eligibility**

Artists age 18 and over are eligible to enter the exhibition.

Art work accepted into any of IMAGES' past juried shows is not eligible for this show.

Media & Specifications: Works in acrylic, oil, water media, pastel, drawing, original print-making, mixed-media, photography, fiber, sculpture, jewelry and ceramics are eligible. No art piece can exceed a height or width of 4 feet. Sculptures must be independently stable. All 2-D work must be framed (unless canvas with wrapped sides) and wired for hanging (NO SAWTOOTH HANGERS ACCEPTED). Each work must be clearly labeled on the back with artist's name, address, telephone #, title of work, media, and price.

# **ENTRY PROCEDURE**

# Up to 5 entries per artist.

\$35 for up to three entries, \$50 for up to 5 images. Submit only digital images of your artwork. Standard JPG format with longest dimension no more than 1700 pixels and no larger than 5MB.

Digital images may also be placed on a CD and named identical to the original artwork title to differentiate each work on the disk. **The CD must be labeled with artist's name and title of each entry.** No CD's will be returned so make a copy for your files.

Entry form, fee (check made to: Images Art Gallery) and CD should be mailed or delivered to: Images Art Gallery, 7320 W 80<sup>th</sup> St., Overland Park, KS 66204 no later than May 17, 2019.
